Can local Conservation Commissions really make a difference? The answer is "Yes - most definitely!" Just ask the Conservation Commissions that presented at the 2023 AVCC Virtual Summit. The theme of our 2023 AVCC Virtual Summit was "Elevating Local Conservation Successes." Seven Conservation Commissions that received Tiny Grants presented their project success stories.

Their stories were educational and inspirational. They shared about their projects' successes, challenges, and lessons learned. But most importantly, they shared how their efforts at the local level were successful in helping to protect Vermont's natural resources. #### **Supporting Vermont's Statewide Conservation Goals**

And speaking of thinking globally, but acting locally, we will have an opportunity to help Vermont support the national goal to conserve at least 30 percent of U.S. lands and freshwater and 30 percent of U.S. ocean areas by 2030. This year, Vermont passed the Community Resilience and Biodiversity Protection Act (Act 59), which states that "... 30 percent of Vermont's total land area shall be conserved by 2030, and 50 percent of the State's total land area shall be conserved by 2050." The exact details of how this will be achieved are being developed. Conservation Commissions across the state have worked hard to identify areas that needed protection and implemented plans to protect those areas. We think that there will be opportunities for Conservation Commissions to be engaged in Vermont's 30x30 and 50x50 initiative. We will be sharing more information about this via the AVCC listserv as it becomes available.

#### Recognizing Nancy Jones' 20+ Years of Service on the AVCC Board

As part of my letter, I would like to recognize and thank one of our Board Members for her years of work. Nancy Jones has served on the AVCC Board for over 20 years. She is also the Chair of the Bradford Conservation Commission and is Co-Chair on Bradford's Conservation Fund Committee. Nancy has been a very active member of the AVCC Board and has filled the role of Secretary for as many years as I can remember. Nancy has been with the AVCC through many changes and has provided the "corporate memory" so to speak for all of us that are relatively new to the Board. Nancy is dedicated to conservation and shows it with action as well as words. We are sorry that Nancy has decided to step down, we will miss her, and we wish her all the best in her future endeavors.

#### **Recruiting New Board Members**

The AVCC Board is made up of 9 individuals – 5 that are appointed by Vermont Natural Resources Council and 4 that are volunteer members. ## TINY GRANT SUCCESS STORIES

#### AN UPDATE FROM 2023 AVCC TINY GRANT PROJECTS

#### **Jericho Pollinator Garden and Tree Care Education**



The Jericho Conservation Commission expanded the pollinator garden in front of the Town Hall by planting a section of pollinator plants in the beds surrounding existing trees and conducted an educational campaign to highlight the importance of wildlife habitat. Using Heather Holms' "soft landings" model of habitat creation, shade tolerant native plants were planted to create an understory under trees, and decorative fencing was installed around the trees to deter foot traffic and soil compaction. Educational signs were installed and used during the Town's Green Tree Celebration to educate visitors about the ecological importance of trees in the life cycle of insects, birds, and other animals.

#### **Mount Holly Star Lake Aquatic Plants Event**

The Mount Holly Conservation Commission hosted a public event at the Old Fellows Hall located at the south end of Star Lake, which featured a lecture on aquatic plants and communities that exist in Start Lake and surrounding lakes and ponds. The event was jointly sponsored by the Conservation Commission and the Farm & Wilderness Conservation, included refreshments, and was attended by approximately 30 town residents.



#### **Putney Buckthorn Removal on Trails**



The **Putney Conservation Commission** used their tiny grant funds to purchase special girdling knives and uprooter tools to remove buckthorn from trails in the East Putney Forest Block, an important wildlife habitat and corridor connecting forested land on either side of Route

5. Once the trail is restored and reconstructed, the commission plans to offer informative nature walks to the community to highlight the conservation value of this 50-acre parcel of land, which includes a stream and small wetland. The tools will be available to the commission for future use at other conservation sites in Putney.



# TINY GRANT SUCCESS STORIES

#### AN UPDATE FROM 2023 AVCC TINY GRANT PROJECTS

#### **Richford Pollinator Garden**

The **Richford Conservation Commission** partnered with the Richford Elementary School to plant a pollinator garden and host a pollinator awareness campaign, distributing free wildflower seed packets to the public. Members and children from the school worked together to plan and plant a pollinator garden, resulting in varied habitat and food sources for pollinators, and enhanced awareness and education on the benefits of wildlife-friendly native plants.



#### **Bolton Boardwalk in Town Forest**

The Bolton Conservation Commission constructed a raised boardwalk on the primary access trail to the Preston Pond Conservation Area, or Bolton Town Forest, that allows visitors access to the trails and abates degradation to the trail and supports core beaver habitat. Members and community volunteers constructed the boardwalk over several workdays.


**To be eligible for an AVCC Tiny Grant, groups must be:** Vermont conservation commissions or local committees/groups that are working towards becoming a conservation commission *AND* paid members of AVCC. To check your membership status, please email vtconservation@gmail.com.

**Other Stipulations**: Groups must be a municipality or IRS certified 501(c)(3) public charity, or have fiscal sponsorship by a municipality or IRS certified 501(c)(3) public charity. Prior recipients of grants from AVCC must have completed those grants and closed them out. Grants cannot be used for general funds, dues or subscriptions. Grantees will be required to submit a Conservation Success Story online using the AVCC website (vtconservation.com/success-stories), presenting evidence of grant completion with photographs and text detailing outcomes and challenges.

**Timetable**: Applications must be submitted (or postmarked if sent by mail) on or before **April 5, 2024**. Grantees will be notified of funding approval by **May 10, 2024**. Projects must be completed and a final report submitted **May 1, 2025**. The funds awarded under this grant will be available approximately a month after the awards are announced. Checks will be issued by the Vermont Community Foundation.


